### WHAT IS THIS PRODUCT?

#### Tvpe

The Shares are a class of shares in Absolute Return Strategies Fund, a sub-fund of CaixaBank Global SICAV. The Fund is organised as a public limited company (société anonyme) governed by the Luxembourg law of 10 August 1915 concerning commercial companies, as amended (the "1915 Law") and is an investment company with variable capital (société d'investissement à capital variable). The Fund qualifies as an undertaking for collective investment in transferable securities (UCITS) within the meaning of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment (the "2010 Law"). The Fund has appointed CaixaBank Asset Management Luxembourg S.A. as its management company (the "Management Company"). The Sub-Fund is a sub-fund of an investment fund, whose performance will depend on the performance of its portfolio as further described in the section "Objectives" of this Key Information Document ("KID").

#### Term

The Fund, the Sub-Fund and the Shares were created for an unlimited duration. The Fund can be dissolved by a resolution of the general meeting of shareholders as further outlined in the articles of incorporation of the Fund (the "Articles"). The PRIIP Manufacturer cannot terminate the Fund, Sub-Fund or the Shares unilaterally.

#### Objectives

The investment objective of the Sub-Fund is to seek capital appreciation with an absolute return regardless of the direction of the market and conservative risk profile through investing in a mixed pool of assets (including equities, fixed income securities, commodities, money market instruments and other UCITS, including Exchange-Traded Funds ("ETFs")) using different liquid alternative investment strategies. The Sub-Fund will focus primarily on non-directional liquid alternative investment strategies (relative value and global macro). However, the Sub-Fund may employ a variety of alternative investment strategies including long short equity, event driven, managed futures and global macro. CaixaBank Asset Management SGIIC, SAU (the "Investment Manager") seeks to achieve the Fund's objective by allocating respective portions of the portfolio of the Sub-Fund to different sub-investment managers which will select assets based on their respect experience of implementing the relevant strategy, current market conditions and the investment objectives of the Sub-Fund. In executing each of these strategies, the sub-investment managers will select and allocate the assets globally without setting limits on any particular asset class (equity or fixed income, for example), geographical region or sector and complying with the relevant UCITS diversification requirements. Some of the main investment strategies to be used include long short equity strategies, relative value strategies, event driven strategies, global macro strategies, managed futures and multi-strategy strategies. In exceptional circumstances when the Investment Manager or any sub-investment manager anticipate adverse market, economic, political or other conditions, the Sub-Fund may invest primarily in money market instruments or equivalents or leave a significant portion of its assets uninvested for defensive purposes. Doing so could help the SubFund avoid losses but may mean lost opportunities. Although the Sub-Fund will concentrate its investments in Organisation for Economic Co-operation and Development ("OECD") countries, the Sub-Fund may also invest in securities of companies located in and governments of Emerging Market Countries, which may involve additional risk, relative to investment in more developed economies. The Sub-Fund may invest in assets denominated in any currency, without limitations. The Sub-Fund may also hold ancillary liquid assets, such as cash in bank deposits at sight held in current accounts with a bank accessible at any time, for up to 20% of its net assets which may only go beyond the 20% limit in case of exceptionally unfavorable market conditions as further described in the prospectus. The Shares are non-distributing: any income generated by the Sub-Fund is reinvested to grow the value of the Shares. Investors may redeem their Shares in the Sub-Fund on each business day in Luxembourg. Taking into account the short-term holding period and the characteristics of the investments, the performance of the Sub-Fund depends on the performance of the investments over time. A positive performance of the investments will lead to a positive performance of the Sub-Fund. Likewise, a negative performance of the investments will cause a negative performance of the Sub-Fund. The Sub-Fund pursues an actively-managed investment strategy. The Sub-Fund refers to HFRU Equity Hedge (the "Benchmark"). The Benchmark is solely used as a reference to compare the performance of the Sub-Fund. The Sub-Fund's investment objective is not to track the performance of the Benchmark. There are no restrictions on the extent to which the Sub-Fund's portfolio and performance may deviate from the ones of the Benchmark. The investments underlying the Sub-Fund do not take into account the EU criteria for environmentally sustainable economic activities<sup>1</sup>. The depositary of the Fund is BNP Paribas, Luxembourg Branch. This KID is available in English and Spanish. The latest price for the Shares is available at the registered office of the Fund, 60, avenue J.F. Kennedy, L-1855 Luxembourg. The Fund is an umbrella fund offering several sub-funds whose assets and liabilities are legally segregated between each other. Such document only describes the class A of the Absolute Return Strategies Fund. Other classes are also available within this Sub-Fund. Further information on such classes is available in the prospectus of CaixaBank Global SICAV. Conversion in and out between sub-funds/classes of shares

within CaixaBank Global SICAV is allowed. Periodic reports and the prospectus, as further outlined in the section "Other relevant information" below, are prepared for the Fund as a whole. #### Intended retail investor

The Shares are intended for retail investors who (i) have sufficient past experience and theoretical knowledge of this kind of investment allowing them to assess the risk of investing in this kind of product, (ii) have a short-term investment horizon of 2 years and (iii) have sufficient resources to be able to bear the loss of their entire capital when investing in the Shares. The need of the retail investor to be able to bear the loss of their entire investment is due to several risks including market and credit risk, which can significantly impact your return on investment. These risks are further described in the section "What are the risks and what could I get in return?" below. Investors should be willing to assume a risk of 2 out of 7, which is a low risk.

#### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### **Risk Indicator**





The risk indicator assumes you keep the product for 2 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

# WHAT HAPPENS IF CAIXABANK ASSET MANAGEMENT LUXEMBOURG S.A. IS UNABLE TO PAY OUT?

The investor may not face a financial loss due to the default of the PRIIP Manufacturer.

The assets of the Fund are held in safekeeping by its depositary, BNP Paribas, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the PRIIP Manufacturer, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations as set out in the agreement with the Depositary).

Losses are not covered by an investor's compensation or guarantee scheme.

#### WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

#### **Costs over Time**

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

# Recommended holding period: 2 years

The Sub-Fund is aimed at investors with a high risk tolerance who assume a perspective of capital appreciation in the short/medium term and, as such, are willing to tie up their savings for a recommended holding period of 2 years.

You can redeem your investment at any time during this period, or hold the investment longer. Investors may redeem their shares of the Sub-Fund on any business day in Luxembourg. Cashing in before the recommended holding period may increase the risk of lower investment returns.
