This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

WHAT IS THIS PRODUCT?

Type

The Shares are a class of shares in CaixaBank Global Iter Fund, a sub-fund of CaixaBank Global SICAV. The Fund is organised as a public limited company (*société anonyme*) governed by the Luxembourg law of 10 August 1915 concerning commercial companies, as amended (the "**1915 Law**") and is an investment company with variable capital (*société d'investissement à capital variable*). The Fund qualifies as an undertaking for collective investment in transferable securities (UCITS) within the meaning of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment (the "**2010 Law**"). The Fund has appointed CaixaBank Asset Management Luxembourg S.A. as its management company (the "**Management Company**"). The Sub-Fund is a sub-fund of an investment fund, whose performance will depend on the performance of its portfolio as further described in the section "Objectives" of this Key Information Document ("**KID**").

Term

The Fund, the Sub-Fund and the Shares were created for an unlimited duration. The Fund can be dissolved by a resolution of the general meeting of shareholders as further outlined in the articles of incorporation of the Fund (the "**Articles**"). The PRIIP Manufacturer cannot terminate the Fund, Sub-Fund or the Shares unilaterally.

Objectives

The investment objective of the Sub-Fund is to provide investors with medium to long-term capital appreciation by investing in a dynamic and diversified portfolio of assets. The Sub-Fund aims to produce returns by investing in multiple asset classes including bonds, money market instruments, equities and currencies and getting exposure to various assets such as commodities and real estate by investing through UCITS. In order to achieve its investment objective, the Sub-Fund will invest a majority of its assets in fixed income securities and other debt or debt-related securities. The Sub-Fund may invest up to 25% of its net assets in equity. For equity markets, the main focus of equity investments will be on European equities and companies with large capitalisations. The Sub-Fund may also use derivatives for the purposes of hedging and efficient portfolio management. The Sub-Fund may invest into funded and unfunded total return swaps. Such instruments may be used to gain exposure on a total return basis to any asset that the Sub-Fund is otherwise permitted to gain exposure in strict accordance with its investment policy and objectives. The percentage of the assets of the Sub-Fund that can be subject to total return swaps transactions, measured by reference to the notional amount of such transactions, is expected to be 0% of the net asset value, with a maximum percentage expected not to exceed 40% of the net asset value. Collateral received by the Sub-Fund may consist of cash. The Sub-Fund will not enter into Securities Financing Transactions ("**SFTs**"). Should the Sub-Fund enter into SFTs in the future, the prospectus will be amended accordingly prior to such use. To achieve its investment goals, for treasury purposes and/or in case of unfavorable market conditions, the Sub-Fund may also invest in money market instruments and transferable securities on an ancillary basis. The Sub-Fund may also hold ancillary liquid assets,

such as cash in bank deposits at sight held in current accounts with a bank accessible at any time, for up to 20% of its net assets which may only go beyond the 20% limit in case of exceptionally unfavorable market conditions as further described in the prospectus. The Shares are non-distributing: any income generated by the Sub-Fund is reinvested to grow the value of the Shares. Investors may redeem their Shares in the Sub-Fund on each business day in Luxembourg. Taking into account the medium-term holding period and the characteristics of the investments, the performance of the Sub-Fund depends on the performance of the investments over time. A positive performance of the investments will lead to the Sub-Fund's positive performance just as a negative performance of the investments will cause a negative performance. The Sub-Fund pursues an actively-managed investment strategy. The Sub-Fund refers to the following Benchmark: 15% MSCI All Countries World Net Total Return Index + 42,5% BofA Merrill Lynch Euro Currency Overnight Deposit Offered Rate Index + 42,5% BofA Merrill Lynch Euro Large Cap Index (the "**Benchmark**"). The Benchmark is solely used as a reference to compare the performance of the Sub-Fund. The Sub-Fund's investment objective is not to track the performance of the Benchmark. There are no restrictions on the extent to which the Sub-Fund's portfolio and performance may deviate from the ones of the Benchmark. The investments underlying the Sub-Fund do not take into account the European Union ("**EU**") criteria for environmentally sustainable economic activities¹. The depositary of the Fund is BNP Paribas, Luxembourg Branch. This KID is available in English, Portuguese and Spanish. The latest price for the Shares is available at the registered office of the Fund, 60, avenue J.F. Kennedy, L-1855 Luxembourg. The Fund is an umbrella fund offering several sub-funds whose assets and

liabilities are legally segregated between each other. Such document only describes the class A of the CaixaBank Global Iter Fund. Other classes are also available within this Sub-Fund. Further information on such classes is available in the prospectus of CaixaBank Global SICAV. Conversion in and out between sub-funds/classes of shares within CaixaBank Global SICAV is allowed. Periodic reports and the prospectus, as further outlined in the

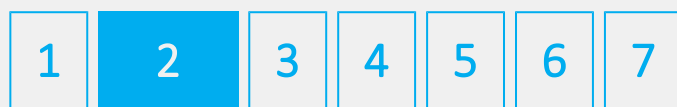

Intended retail investor

The Shares are intended for retail investors who (i) have sufficient past experience and theoretical knowledge of this kind of investment allowing them to assess the risk of investing in this kind of product, (ii) have a medium-term investment horizon of 4 years and (iii) have sufficient resources to be able to bear the loss of their entire capital when investing in the Shares. The need of the retail investor to be able to bear the loss of their entire investment is due to several risks including market risk, which can significantly impact your return on investment. These risks are further described in the section "What are the risks and what could I get in return?" below. Investors should be willing to assume a risk of 2 out of 7, which is a low risk.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Synthetic Risk Indicator



The risk indicator assumes you keep the product for 4 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and

poor market conditions are very unlikely to impact our capacity to pay you. Further information is disclosed in the sections "Risks Considerations" and "Conflict of Interest" of the Fund's prospectus.

This product does not include any protection from future market performance so you could lose some or all of your investment.

WHAT HAPPENS IF CAIXABANK ASSET MANAGEMENT LUXEMBOURG S.A. IS UNABLE TO PAY OUT?

The investor may not face a financial loss due to the default of the PRIIP Manufacturer.

The assets of the Fund are held in safekeeping by its depositary, BNP Paribas, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the PRIIP Manufacturer, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations as set out in the agreement with the Depositary).

Losses are not covered by an investor's compensation or guarantee scheme.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and the performance of the product. - In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 4 years

The Sub-Fund is aimed at investors with a high risk tolerance who assume a perspective of capital appreciation in the short/medium term and, as such, are willing to tie up their savings for a recommended holding period of 4 years.

You can redeem your investment at any time during this period, or hold the investment longer. Investors may redeem their shares of the Sub-Fund on any business day in Luxembourg. Cashing in before the recommended holding period may increase the risk of lower investment returns.
