## WHAT IS THIS PRODUCT?

### Type

The Units are a class of units in BPI Africa (the "Sub-Fund"), a sub-fund of BPI Global Investment Fund (the "Fund"). The Fund is formed as a fonds commun de placement. The Fund qualifies as an undertaking for collective investment in transferable securities (UCITS) within the meaning of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment. CaixaBank Asset Management Luxembourg S.A. is acting as management company of the Fund (the "Management Company"). The Sub-Fund is a sub-fund of an investment fund, whose performance will depend on the performance of its portfolio as further described in the section "Objectives" of this KID.

### Term

The Fund, the Sub-Fund and the Units were created for an unlimited duration. The Fund can be dissolved by a decision of the Management Company as further outlined in the prospectus of the Fund. The PRIIP Manufacturer in its capacity as management company can terminate the Fund, Sub-Fund or the Units unilaterally.

### Objectives

The investment objective of the Sub-Fund is to provide investors with long-term capital appreciation, based on risk spreading and future potential growth. The Sub-Fund will mainly invest in equity securities issued by African companies (companies having their head office in Africa or listed in Stock Markets in African countries) and/or companies that have significant operations in Africa. The Sub-Fund aims to produce returns by investing in multiple asset classes including equity securities, non-voting preferred stocks, bonds with acquisition rights, convertible bonds, warrants or any other financial instruments that attribute a subscription right, are convertible or have their performance linked to shares issued by African companies and companies that have significant activities in Africa and where it considers the risk to be appropriate. The Sub-Fund may invest in transferable securities and money market instruments in eligible markets too, namely on the following markets: Benin, Botswana, Burkina Faso, Egypt, Ghana, Guinea Bissau, Ivory Coast, Kenya, Mali, Mauritius, Morocco, Namibia, Niger, Nigeria, Senegal, South Africa, Tanzania, Togo, Tunisia, Uganda, Zambia, Zimbabwe. Up to 10% of the Sub-Fund's net asset value may be invested in other UCITS which have similar investment policies. The Sub-Fund may also use derivatives for the purposes of hedging and efficient portfolio management. The Sub-Fund will not enter into total return swaps. The Sub-Fund will not enter into Securities Financing Transactions ("SFTs"). To achieve its investment goals, for treasury purposes and/or in case of unfavorable market conditions, the Sub-Fund may also invest in money market instruments and transferable securities on an ancillary basis. The Sub-Fund may also hold ancillary liquid assets, such as cash in bank deposits at sight held in current accounts with a bank accessible at any time, for up to 20% of its net assets which may only go beyond the 20% limit in case of exceptionally unfavorable market conditions as further described in the prospectus. The Units are non-

distributing: any income generated by the Sub-Fund is reinvested to grow the value of Units of the Sub-Fund. The Units may be subscribed and redeemed upon demand on each Luxembourg banking day. Taking into account the medium/long-term holding period and the characteristics of the investments, the performance of the Sub-Fund depends on the performance of the investments over time. A positive performance of the investments will lead to the Sub-Fund's positive performance just as a negative performance of the investments will cause a negative performance. The Sub-Fund pursues an actively-managed investment strategy. The Sub-Fund does not refer to a benchmark. The investments underlying the Sub-Fund do not take into account the European Union ("EU") criteria for environmentally sustainable economic activities<sup>1</sup>. The depositary of the Fund is BNP Paribas, Luxembourg Branch. This KID is available in English, Portuguese, Spanish, German and French. Kennedy L-1855 Luxembourg. The Fund is an umbrella fund offering several sub-funds whose assets and liabilities are legally segregated between each other. Such document only describes the class M of the BPI Africa. Other classes are also available within this Sub-Fund. Conversion in and out between sub-funds/classes of units within BPI Global Investment Fund is allowed. ## Intended retail investor

The Shares are intended for retail and institutional investors who (i) have sufficient past experience and theoretical knowledge of this kind of investment allowing them to assess the risk of investing in this kind of product, (ii) have a medium-term investment horizon of 5 years and (iii) have sufficient resources to be able to bear the loss of their entire capital when investing in the Shares. The need of the retail/institutional investor to be able to bear the loss of their entire investment is due to several risks including market risk, which can significantly impact your return on investment. These risks are further described in the section "What are the risks and what could I get in return?" below. Investors should be willing to assume a risk of 3 out of 7, which is a medium-low risk.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Synthetic Risk Indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low

level, and poor market conditions are very unlikely to impact our capacity to pay you.

## WHAT HAPPENS IF CAIXABANK ASSET MANAGEMENT LUXEMBOURG S.A. IS UNABLE TO PAY OUT?

The investor may not face a financial loss due to the default of the PRIIP Manufacturer.

The assets of the Fund are held in safekeeping by its depositary, BNP Paribas, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the PRIIP Manufacturer, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations as set out in the agreement with the Depositary).

Losses are not covered by an investor's compensation or guarantee scheme.

## WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and the performance of the product. ## HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

### Recommended holding period: 5 years

The Sub-Fund is aimed at investors with a high risk tolerance who assume a perspective of capital appreciation in the medium/long term and, as such, are willing to tie up their savings for a recommended holding period of 5 years.

You can redeem your investment at any time during this period, or hold the investment longer. For Units subscribed for less than 180 calendar days, a redemption charge of up to 3% may apply. Investors may redeem their shares of the Sub-Fund on any business day in Luxembourg. Cashing in before the recommended holding period may increase the risk of lower investment returns.
