BPI Global Investment Fund is managed by Caixabank Asset Management Luxembourg S.A.

#### Objectives and investment policy

The investment objective of the Sub-Fund is to provide Unitholders with medium to long-term capital appreciation by investing in a dynamic and diversified portfolio of assets.

The Sub-Fund aims to produce returns by investing in a diversified portfolio of mainly equity securities, including common stocks, preferred stocks, warrants, securities convertible into common stock or other securities indexed to stocks of companies, which in the opinion of the Management Company have a strong potential for growth and where it considers the risk appropriate for the Sub-Fund, in compliance with the investment limits and guidelines of the Fund (as set forth in section 3 of the Prospectus).

For equity markets, the Sub-Fund may invest worldwide and without limitations about region, sector, style or market capitalization. The Sub-Fund may maintain high exposure to small capitalization companies in certain management periods, up to 80% of the net asset value of the Sub-Fund.

In addition, the Sub-Fund may invest in public and private debt securities, short-term securities (namely deposit certificates, deposits, interbank applications, commercial bills, treasury bills) and up to 10% of the Sub-Fund's net asset value in other UCITS. They will have an average investment grade (equivalent AAA and BBB- as defined by Standard and Poor's).

The Sub-Fund may use financial derivative instruments for the purpose of efficient portfolio management and hedging. The Sub-Fund will not enter into securities financial transaction - SFTs - nor total return swaps - TRS.

The Sub-fund pursues an actively-managed investment strategy.

The Sub-fund refers to the following Benchmark: MSCI Europe Total Return Net Index (ticker: MSDEE15N Index).

The benchmark is indicated for information purposes only, and the Fund manager does not intend to track it or to limit the Sub-fund's portfolio to the constituents of the Benchmark. There are no restrictions on the extent to which the Sub-Fund's portfolio and performance may deviate from the ones of the Benchmark.

Units in this Sub-Fund may be subscribed and redeemed upon demand on every Luxembourg Banking Day.

The Minimum Subscription Amount for Class E Units is EUR 300.000.

The Sub-Fund only offers capitalisation Units and therefore the income arising from the Sub-fund is not distributed.

The investments underlying the Sub-Fund do not take into account the EU criteria for environmentally sustainable economic activities which are determined by the Regulation (EU) 2020/852 of the European Parliament and of the Council of 18 June 2020 on the establishment of a framework to facilitate sustainable investment, as amended from time to time.

**Recommendation:** this Sub-Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

**Why this category?** The Sub-Fund is in this specific category because it has shown a high level of volatility.

The main risks the Sub-Fund will face are equity market, interest rate and currency volatility. The Sub-Fund will also be exposed to liquidity risk as there are no restrictions to a minimum market capitalization required neither

geographically. More residual is the exposure to counterparty risk, that will be assumed by OTC exposures and interest rate/issuer specific risk from exposures to a fixed income assets.

In particular the following risks factors must be considered for the Sub-Fund:

- The risk of devaluation of the assets of the Sub-Fund, which depends among other factors on the perspectives of economical growth and future profits from companies.

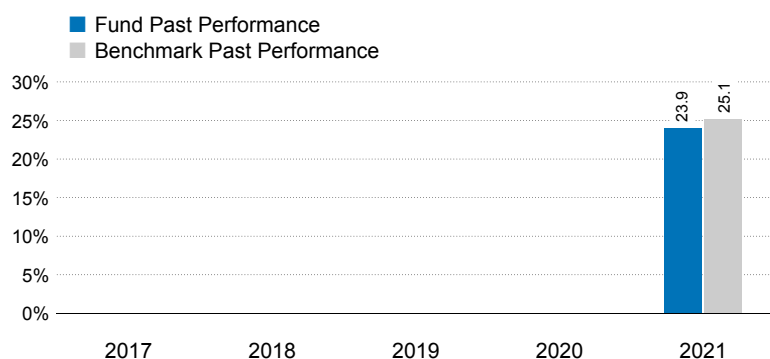
