This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

WHAT IS THIS PRODUCT?

Type

The Shares are a class of shares in CaixaBank Wealth Kotinos Fund of Funds, a sub-fund of CaixaBank Wealth SICAV. The Fund is organised as a public limited company (*société anonyme*) governed by the Luxembourg law of 10 August 1915 concerning commercial companies, as amended (the "1915 Law") and is an investment company with variable capital (*société d'investissement à capital variable*). The Fund qualifies as an undertaking for collective investment in transferable securities (UCITS) within the meaning of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment (the "2010 Law"). The Fund has appointed CaixaBank Asset Management Luxembourg S.A. as its management company (the "Management Company"). The Sub-Fund is a sub-fund of an investment fund, whose performance will depend on the performance of its portfolio as further described in the section "Objectives" of this Key Information Document ("KID").

Term

The Fund, the Sub-Fund and the Shares were created for an unlimited duration. The Fund can be dissolved by a resolution of the general meeting of shareholders as further outlined in the articles of incorporation of the Fund (the "Articles"). The PRIIP Manufacturer cannot terminate the Fund, Sub-Fund or the Shares unilaterally.

Objectives

The investment objective of the Sub-Fund is to provide investors with capital growth, by investing most of its assets in eligible fixed income and equity UCITS. The Sub-Fund will invest at least 60% of its net assets in other UCITS, including eligible Exchange-Traded Funds ("ETFs"). As such, the Sub-Fund qualifies as a fund of funds. A main part of the Sub-Fund's net assets will be invested into fixed income UCITS or directly into fixed income securities. The fixed income securities such UCITS are investing in or the Sub-Fund is directly investing in include government bonds, credit bonds, emerging market bonds, convertible bonds, covered bonds and high yield bonds. The Sub-Fund will not invest more than 20% of its net assets, directly or through UCITS, into high yield bonds. Where the Sub-Fund invests directly into fixed income securities and there is a rating downgrade, a corporate action or other conversions (including corporate restructuring events), the 20% limit referred to above may be exceeded on a temporary basis. In this case, CaixaBank Asset Management, S.G.I.I.C., S.A. (the "Investment Manager") will seek to reduce its exposure to those instruments as soon as practicable whilst having regard to the best interest of the investors. If market conditions so allow and if so required to achieve its investment objective, the Sub-Fund's exposure to equity UCITS and to equity securities directly may reach up to 50% of net assets in aggregate, it being understood that at all times, at least 60% of the net assets of the Sub-Fund are invested into other UCITS including eligible ETFs. Indirect and direct investments of the Sub-Fund will in principle be made into developed markets. The exposure to emerging markets is limited to 15% of the Sub-Fund's net assets. The Sub-Fund may invest up to 10% of its net assets into UCITS (including eligible ETFs) that are exposed to commodities and real estate respectively. The Sub-Fund will not enter into Securities

Financing Transactions ("SFTs"). The Sub-Fund will not enter into total return swaps. To achieve its investment goals, for treasury purposes and/or in case of unfavorable market conditions, the Sub-Fund may also invest in money market instruments and transferable securities on an ancillary basis. The Sub-Fund may also hold ancillary liquid assets, such as cash in bank deposits at sight held in current accounts with a bank accessible at any time, for up to 20% of its net assets which may only go beyond the 20% limit in case of exceptionally unfavorable market conditions as further described in the prospectus. The Sub-Fund may use derivatives for the purpose of efficient portfolio management, hedging and to implement investment strategies which aim to achieve the Sub-Fund's investment objective. The Sub-Fund will in principle not make an extensive use of derivatives. The Sub-Fund may invest in derivatives in the form of futures and options traded in official markets including, but not limited to, EUREX, CMT, CBOT and MEFF, and/or in financial derivative instruments dealt in over-the counter ("OTC derivatives"), such as credit default swaps. The Shares are non-distributing, any income generated by the Sub-Fund is reinvested to grow the value of Shares. Investors may redeem their Shares in the Sub-Fund on each business day in Luxembourg. Taking into account the long-term holding period and the characteristics of the investments, the performance of the Sub-Fund therefore depends on the performance of the investments over time. A positive performance of the investments will lead to the Sub-Fund's positive performance just as a negative performance of the investments will cause a negative performance. The Sub-Fund pursues an actively-managed investment strategy. For indicative purposes only, the Sub-Fund refers to the following benchmark: 9,50% MSCI Europe TR Net + 10,00% MSCI USA TR Net (USD) + 1,50% MSCI Japan

TR Net (JPY) + 4,00% MSCI Emerging Markets TR Net (USD) + 11,00% ICE BofA 1-3Y All Euro Government + 28,00% ICE BofA 3-5Y All Euro Government + 11,00% ICE BofA 3-5Y Euro Corporate + 25,00% ICE BofA ESTR Overnight Rate Index (the "**Benchmark**"). The Benchmark is solely used as a reference to compare the performance of the Sub-Fund and the Investment Manager does not intend to track it or to limit the Sub-Fund's portfolio to the constituents of the Benchmark. The Sub-Fund may significantly deviate from this Benchmark. The investments underlying the Sub-Fund do not take into account the European Union ("EU") criteria for environmentally sustainable economic activities¹. The depositary of the Fund is BNP Paribas, Luxembourg Branch. This KID is available in English and Spanish. The latest price for the Shares is available at the registered office of the Fund, 60, avenue J.F. Kennedy, L-1855 Luxembourg. The Fund

is an umbrella fund offering several sub-funds whose assets and liabilities are legally segregated between each other. Such document only describes the class A of the CaixaBank Wealth Kotinos Fund of Funds. Other classes are also available within this Sub-Fund. Further information on such classes is available in the prospectus of CaixaBank Wealth SICAV. Conversion in and out between sub-funds/classes of shares within CaixaBank Wealth SICAV is allowed. Periodic reports and the prospectus, as further outlined in the section "Other relevant information" below, are prepared for the Fund as a whole. Intended retail investor

The Shares are intended for retail investors who (i) have sufficient past experience and theoretical knowledge of this kind of investment allowing them to assess the risk of investing in this kind of product, (ii) have a medium-term investment horizon of 5 years and (iii) have sufficient resources to be able to bear the loss of their entire capital when investing in the Shares. The need of the retail investor to be able to bear the loss of their entire investment is due to several risks including market risk, which can significantly impact your return on investment. These risks are further described in the section "What are the risks and what could I get in return?" below. Investors should be willing to assume a risk of 2 out of 7, which is a low risk.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Synthetic Risk Indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and

WHAT HAPPENS IF CAIXABANK ASSET MANAGEMENT LUXEMBOURG S.A. IS UNABLE TO PAY OUT?

The investor may not face a financial loss due to the default of the PRIIP Manufacturer.

The assets of the Fund are held in safekeeping by its depositary, BNP Paribas, Luxembourg Branch (the "**Depositary**"). In the event of the insolvency of the PRIIP Manufacturer, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations as set out in the agreement with the Depositary).

Losses are not covered by an investor's compensation or guarantee scheme.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and the performance of the product. The amounts shown here are illustrations based on an example investment amount and different investment periods. We have assumed:

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 5 years

The Sub-Fund is aimed at investors with a high risk tolerance who assume a perspective of capital appreciation in the medium/long term and, as such, are willing to tie up their savings for a recommended holding period of 5 years.

You can redeem your investment at any time during this period, or hold the investment longer. Investors may redeem their shares of the Sub-Fund on any business day in Luxembourg. Cashing in before the recommended holding period may increase the risk of lower investment returns.
